

2. Background

The MADHYA PRADESH TOURISM BOARD (MPTB) (the "Authority") has been formed with the objective of promoting tourism in the state of Madhya Pradesh. The Government of Madhya Pradesh, Department of Tourism has issued a policy for allotment of Government land/Heritage property for development of the Tourism Project and establish operation and the maintenance thereof till the period of 90 (ninety) years in accordance with the terms and conditions of RFP documents and as per the Tourism Policy (2016) Amended 2019. The Authority has been appointed as the nodal agency for the allotment of land and Heritage Property.

Expression of Interest (EOI) is invited from experienced Chartered Accountant Firms **For Scrutiny of Eligibility of Technical Bids** received under Inviting RFP as per the terms & conditions of RFP documents and as per the Tourism Policy (2016) Amended 2019.

3.0 Scope of Work:

- 3.1 Scrutiny of Eligibility of Technical Bids received under Inviting RFP as per the terms & conditions of RFP documents and as per the Tourism Policy (2016) Amended 2019 shall be carried by CA Fims.
- 3.2 To prepare the Evaluation sheet as per Eligibility conditions of the RFP documents.
- 3.3 To submit the signed technical and financial evaluation sheet within time as mentioned in the work order.
- 3.4 To present at MPTB office on opening of technical bids and financial bids.
- 3.5 Scrutiny of Eligibility of Technical Bids documents shall be carried at MPTB office.
- 3.6 The CA firm is under an obligation to keep confidential in relation to the scrutiny, bid process, ("Confidential Information"), and Confidential Information shall not be disclosed to third party without the prior written consent of the Authority.

4.0 **Scrutiny Fee**

- 4.1 The Scrutiny fee shall be Rs. 2,000 per bid plus GST as applicable (inclusive of all charges).
- 4.2 The Scrutiny fees will be payable only after completion of bid process.

5.0 Eligibility criteria:

- 5.1 A Chartered Accountant firm should have head office/branch office at Bhopal (Detail address to be submitted);
- 5.2 The firm must be on the approved panel of Comptroller and Auditor General of India (CAG of India) for the year 2022-23 (Copy of CAG empaneled certificate to be submitted);
- 5.3 The firm must be a Partnership or LLP having minimum 10 years of existence (Copy of registration of CA firm to be submitted);
- 5.4 Average annual turnover of the firm during last three years (2020-21, 2021-22 and 2022-23) should not be less than Rs. 50 Lakhs (Proof of turnover i.e. Audited P&L Account & Balance Sheet to be submitted);

- 5.5 The firm or any partner of the firm should not have been blacklisted by or any other organization in respect of any assignment or behavior. Authorized signatory(s) of the firm shall submit an undertaking to this effect.
- 5.6 For this assignment the firm should deploy one qualified Chartered Accountant with relevant experience.
- 5.7 The firm must have conducted at least 10 nos. Internal audit/ statutory audit/ Con-current audit/ financial advisory assignment in Government sector and PSU during 2020-21, 2021-22 and 2022-23.
- 5.8 The firm shall submit relevant documents duly signed by the authorized signatory, in support of the eligibility criteria given above.
- 5.9 Joint venture firm shall not be considered for the assignment.

Note: All necessary documents in support of above eligibility criteria shall be attached with the application.

6.0 PROCEDURE FOR SELECTION

- 6.1 MPTB plans to empanel not more than 4 agencies .
- 6.2 The duration of engagement shall be for a period of three years, extendable for a further period on the same terms and conditions subject to satisfactory performance.
- 6.3 The applications should be complete in all criteria as mentioned in this document. Incomplete proposals will be liable for summary rejection.
- 6.4 All the applications received will be scrutinized to assess their eligibility based on the qualifying criteria and other requirements. Those proposals which do not meet the qualifying criteria are liable to be rejected forthwith.
- 6.5 **MPTB** shall shortlist the Firms based on the requirements and the responses submitted. MPTB reserves the right to call only Firms for a **technical presentation /meeting** of their proposed Work on the date and time decided by MPTB. The decision taken by the committee in this regard would be final and binding on all the applicants of EOI.
- 6.6 If any information or Document provided in the response to this EOI is found to be misleading subsequently, the Applicant will be disqualified.
- 6.7 **MPTB** may reject any or all the applications received/cancel the entire process at any stage without assigning any reason whatsoever.
- 6.8 The applicants who wish to submit applications to this EOI should note that they should abide by all the terms and conditions contained in the EOI. If the applications contain any extraneous conditions put in by the applicants, such applications may be disqualified and may not be considered for the empanelment/selection process.
- 6.9 The information exchanged between the Applicants and **MPTB** as part of this EOI shall be confidential and shall not be disclosed without the prior written consent of the **MPTB**.

- 6.10 Notwithstanding anything contained hereinabove, in case of any dispute, claim and legal action arising out of this EOI, the parties shall be subject to the jurisdiction of courts at Bhopal, Madhya Pradesh State, India only.
- 6.11 If the "Applicant(s)", at any point of time, wishes not to participate in this EOI, the same information may be communicated to the 'MPTB' within one week of the receipt of this EOI by the "Applicant(s)"

7.0 Submission of applications

This EOI is advertised through selected newspapers and is posted on the website https://www.mptenders.gov.in/. Government of Madhya Pradesh to give wide publicity and invite a large number of eligible "Applicants" who have the capability to deliver such services, for their participation in the process of Expression of Interest. The information provided by the "Applicant(s)" will be used by the 'MPTB' to select potential "Applicant". The format for submission of EOI application is enclosed as Annexure 1 to Annexure 3.

Applicants qualifying as per the criteria mentioned above and who are interested in providing the services detailed above may submit their applications to this EOI as per formats given in annexure along with relevant Documentary evidence latest by **18/10/2023** at **16:00** Hours at e-Procurement portal of GoMP: https://www.mptenders.gov.in/. Any applications not containing information for all the parts of Annexure may be rejected.
